11:20	<p style="text-align: center;">Structural and Building Investigation</p> <p>Whilst building failures are sometimes related to new or unforeseen circumstances, the majority of problems we investigate arise from known criteria, and the genesis can exist anywhere within the initial design concept to the actions of a site operative during installation. Whether investigating a failed detail or a complete system, we will investigate, where necessary, the type of contract used, the location of design responsibility and the site quality control protocols.</p> <p>It is not our experience that failures are the result of roguish behaviour, but more often the result of the simplest of misunderstandings. 14:00	<p style="text-align: center;">Circular Economy and the Built Environment</p> <p>This session will explore the latest developments in the area of circular economy and the built environment. This includes areas such as material passports, reversible building design, measuring circularity, policy developments and real life pilots that illustrate circular economy in action in the built environment. The short & informative sessions will be rounded off with an opportunity to ask questions and gain further insight from around Europe. BRE are a key partner in the EU R&D project – Buildings as Material Banks (BAMB) which concludes in early 2019.</p> <p>A key output from this work is development of a ‘circular building assessment’ methodology and its application, making use of data extractable from BIM (Building Information Modelling). This builds upon many years work in the field of construction & demolition resource efficiency which is still a priority for improvement and firmly embedded into BRE standards, such as BREEAM, and products, such as Smartsite.
